## Notes from the April Senate Meeting

At the April 23, 2015 Senate meeting the Senate voted in favor of a **PCC Proposal to Establish an Area of Concentration in Health Equity for the Master of Public Health**, which was presented by Gregory Miller, Chair of the **Programs, Curricula, and Courses (PCC) Committee**. Miller likewise presented a **PCC Proposal to Establish an Area of Concentration in Health Policy Analysis and Evaluation for the Master of Public Health**, which passed, as well. The Senate also approved the **Addition of a User Experience Working Group to the IT Council**, which was

presented by Jess Jacobson, Chair of the **Elections, Representation, & Governance (ERG) Committee**. Terry Owen, Chair of the **Equity, Diversity, & Inclusion (EDI) Committee** also presented changes to the **Interim UMD Sexual Misconduct Policy**, which were overwhelmingly approved. Lastly, Devin Ellis, Chair of the **Faculty Affairs Committee** presented two reports to the Senate: **UM Guidelines for Appointment, Evaluation, and Promotion of Professional Track Faculty** and **Consideration of a New Post-Doctoral Title**, both of which were amended and then approved.

**T**he **Faculty Affairs Committee** is currently reviewing a charge related to **Faculty Leave Policies**, while the **Equity, Diversity, & Inclusion (EDI) Committee** continues to work on its charge regarding **Policies and Procedures Governing Preferred/Primary Names and Sex/Gender Markers in University Databases**. Also, the **Academic Procedures and Standards (APAS) Committee** is working on two new charges related to a **Proposed Policy on Excused Absence** and a **Suggested Revision to the Academic Clemency Policy**, while it finishes its work on a **Review of Interim Policy and Procedures Concerning Credit for Prior Learning**. Lastly, the **Committee on Committees** will commence its work on committee memberships after the Annual Transition of the Senate.



## Committee News



### From the Senate Chair

**T**here are two April meetings because of the many important issues that are being finished before the May transition, when our new Senators attend and vote for the next Chair-elect and a suite of elected committees and councils. Our April 23rd meeting followed the tradition of being a busy one, as committees reported their charges for final approval. The Campus Affairs Committee submitted its annual Safety Report detailing safety and security issues

and providing data on the top concerns of our faculty, staff, and students. The Equity, Diversity, and Inclusion Committee brought forth its recommendations for changes to the Interim Sexual Misconduct Policy, which engendered a good deal of debate. The passage provides the overall policy document, while other Senate committees continue to work on the investigation and adjudication procedures for students, faculty, and staff.

During the past year, the non-tenure track faculty title was changed to Professional Track (PTK) Faculty, in order to recognize the importance of these professionals on our campus. The Faculty Affairs Committee presented its proposal to establish Guidelines for Appointment, Evaluation, and Promotion of PTK Faculty. Amendments were proposed during the debate, which ended with Senate approval of the amended report. This represents another step in our quest to provide PTK faculty with appropriate recognition and career paths for their contributions.

I noted during my Chair's Report that the period to volunteer for Senate committees would remain open until April 30th and urged everyone to consider them, as well as prompt their colleagues to volunteer. Shared governance at our University is needed to provide reasoned input to the administration on issues of our common concern. I urge you to consider volunteering in order to ensure that shared governance remains strong at UMD.
