Notes from the April Senate Meeting

 Λ t the April 19, 2012 Senate meeting, the Senate voted in favor of two family friendly initiatives at UMD - the recommendations from the 2012 review of the Family Care Resource and Referral Service, and proposed policies for parental leave for faculty. The Senate also voted in favor of creating representation for the Department of Intercollegiate Athletics on the University **Senate** via ex-officio roles and a voting single member constituency Senator seat for head coaches. In addition, the Senate approved the

revised College of Education Plan of Organization to align with the recently reorganized College. Senators also voted in favor of recommendations to change the minimum average in all courses applied to undergraduate major **requirements**; this would create a minimum standard for completing undergraduate degree requirements at the University. Finally, the Senate voted to return the **proposal to** change the Committee on the Review of Student Fees (CRSF) operating procedure to the Student Affairs Committee for further review.

The Student Conduct Committee will carry over its work on the Expansion of Promoting Responsible Action in Medial Emergencies legislation, while the Staff Affairs Committee will continue to work on the Proposed Policy for Parental Leave for Staff. Committee's review of a proposal to implement a retroactive withdrawal policy at the University of Maryland will be passed on to next year's committee for continued research and deliberations. A number of proposals from the **Programs**, **Curricula**, and

Senate meeting was the overwhelming approval of the University of Maryland Policy on Faculty Parental Leave (76 in favor, 4 opposed, 2 abstentions); if approved by the President, any related University policies will be amended to align with this new policy. University colleagues can obtain details regarding these crucial issues on the Senate

website. Also, Chair Kasischke announced that the Senate and President Loh are establishing a Joint Task Force to review the Sexual Harassment Policies and Procedures at the University. These are two vital issues regarding our conditions of work, and I'm pleased to report that we are moving forward on both. Stay tuned for further developments on these fronts.
